### Presidents Message

Well, as we are all celebrating the end of 2020, we have some good things to look forward to despite our disappointment with some of the Federal Election results last November. IFC's efforts to increase our pro-gun majorities in the Iowa House and Senate paid off, leading to the second passing of the Freedom Amendment on January 28<sup>th</sup>. The job ahead is a big one, and that's to educate enough Iowa voters to ensure the passage of this important Constitutional Amendment in 2022. If you haven't seen the text that will be before the voters next year, here it is;

***“The right of the people to keep and bear arms shall not be infringed. The sovereign state of Iowa affirms and recognizes this right to be a fundamental individual right. Any and all restrictions of this right shall be subject to strict scrutiny.”***

We as an organization still have legislative goals for this session, many of them are still in progress, so I'll ask that you just continue to watch for Action Alerts and our new IFC website for updates.

Please mark your calendars for an important event;

Our annual Second Amendment Lobby Day and Rally at the Iowa State Capitol Rotunda are scheduled for February 25<sup>th</sup> at 1:30 PM.

I look forward to seeing as many of you as possible at this event.

Until then, shoot straight, speak the truth, and never stop defending your freedoms.

The 89th session of the Iowa General Assembly was gavelled into session on January 11, 2021.

**FREEDOM AMENDMENT PASSES BOTH THE IOWA HOUSE AND SENATE!** - Iowa is one of only six states that do not have wording in their state constitutions to protect our right to keep and bear arms. After years of hard, diligent work, IFC has helped to move this amendment forward. The Freedom Amendment has been passed by both the Iowa House and Senate. That means it will be headed to the people of Iowa for a vote in 2022. We still need to keep our eye on the ball if we hope to get this passed. The light at the end of the tunnel is near. As a team, we can get this done. Attend IFC 2A day at the Capitol on Feb 25th and let your state reps know that you support this amendment.

**ANTI GUN BILLS INTRODUCED AND ALREADY CONSIDERED DOA** - Here is a list of the bills that have been introduced and already killed by our 2A friendly members of the legislature:

HF24 - An Act relating to firearm violence protective orders and making penalties applicable.

HF65 - An Act relating to the issuance, denial, suspension, or revocation of a permit to carry weapons and a permit to acquire pistols or revolvers.

HF126 - An Act prohibiting the carrying, transportation, or possession of firearms in the capitol building and on capitol grounds, and making penalties applicable.

HF127 - An Act prohibiting the manufacture, possession, shipment, transportation, or receipt of a multi-burst trigger activator, and providing penalties.

HF128 - An Act relating to the sale or transfer of firearms, providing penalties, and including applicability provisions.

HF129 - An Act prohibiting the sale, transfer, or possession of large capacity ammunition feeding devices

providing penalties, and including effective date and applicability provisions.

**HF130** - An Act relating to law enforcement profiling by standardizing collection and centralizing the compilation and of officer stop and compliance data, providing for officer training, creating a community policing advisory board, providing for penalties and remedies, and including effective date provisions.

**HF131** - An Act prohibiting the sale or transfer of semiautomatic assault weapons, providing penalties, and including effective date and applicability provisions.

Our Featured Firearm this quarter comes from our very own organization President, Dave Funk. Dave tells us that on his grass-alfalfa farm in western Marion County, he's always on the lookout for coyotes and woodchucks. With a good population of trophy deer, turkey, quail, and pheasant, he tries to keep the numbers in balance with the habitat. Dave believes that every farm or ranch owner needs a good utility rifle suitable for their property so a few years ago he had Controlled Chaos Arms order in a Howa, Mini Action, heavy barreled rifle in 6.5 Grendel caliber from Brownells. CCA threaded the barrel and Cerakoated it. After some test shooting with the factory stock, he decided to swap it out to a chassis system and had Creative Arms install one of their suppressor tubes after they shortened the barrel, pinning it on to keep it a legal rifle length.

Today it shoots 95gr V-max bullets at 2300fps out of a 10.5" barrel and is very effective on coyotes and woodchucks out past 300 yards, which is the maximum safe distance he can shoot on his property. ### **CHEESE CHOWDER**

3 cups water  
4 medium potatoes (cubed)  
1 cup celery (sliced)  
1 cup carrots (sliced)  
1 large onion (diced)  
2 tsp salt  
¼ tsp pepper  
½ cup butter  
½ cup flour  
1 cup cheddar cheese  
2 cups ham, cubed  
Hot sauce (to taste)  
4 cups milk

Boil water, add veggies, salt and pepper. Simmer for 10-15 mins. Melt butter in a large saucepan. Blend flour in and then gradually stir in milk. Cool over medium heat, stirring constantly until mixture thickens. Add cheese, stir until melted. Stir cheese mixture into veggies. Add ham, hot sauce. Soup tastes better if cooled the day before eating. When reheating, add milk if it's too thick.
